NOTICE TO PARENTS/GUARDIANS OF STUDENT-ATHLETES

Due to the COVID-19 pandemic during the 2019-20 school year and the continued stress on the medical community, the Indiana High School Athletic Association, Inc. ("IHSAA") waived the provisions of Rule 3-10 for the 2020-21 school year. Effective immediately, valid physical and consent forms presented to member schools on behalf of eligible students during the 2019-20 school year are valid during the upcoming 2020-21 school year.

Northern Wells Community Schools is notifying parents/guardians of this IHSAA rule change for the upcoming 2020-2021 school year and requesting that those parents/guardians that wish to have their student's athletic physical transferred from the 2019-2020 school year to the 2020-2021 school year provide written consent prior to any athletic participation. The prior forms completed for the 2019-2020 school year that are being transferred are the following:

- Preparticipation Physical History and Physical Examination
- Consent & Release Certificate
- Concussion & Sudden Cardiac Arrest Acknowledgement

Parents/guardians not wishing to provide the Student-Athlete Consent Transfer form in order to transfer forms from the 2019-2020 school year to the 2020-2021 school year will be required to either secure a new athletic physical or execute new consent forms prior to athletic participation for the 2020-2021 school year.
